We would rather spend more time going deep into a good question rather than rushing from one question to the next. Therefore, we will pick and choose the best questions.





I want to ask that I am from Pakistan, so I cannot create an ACX account. So I have to purchase an LLC. I have experience registering LLCs, and that's not a problem. But I want to register LLC in New Mexico as the registration fee is only 50\$, and there is no annual recurring fee. Also, there is nearly 5% income tax and no sales tax. Income tax becomes payable if the income crosses the threshold of \$500,000 annually. So considering these things, I decided to go with New Mexico. Does this sound right to you guys?

After registering LLC (as I told in previous question), can I move my KDP account to new details as it is on Pakistani details currently?
