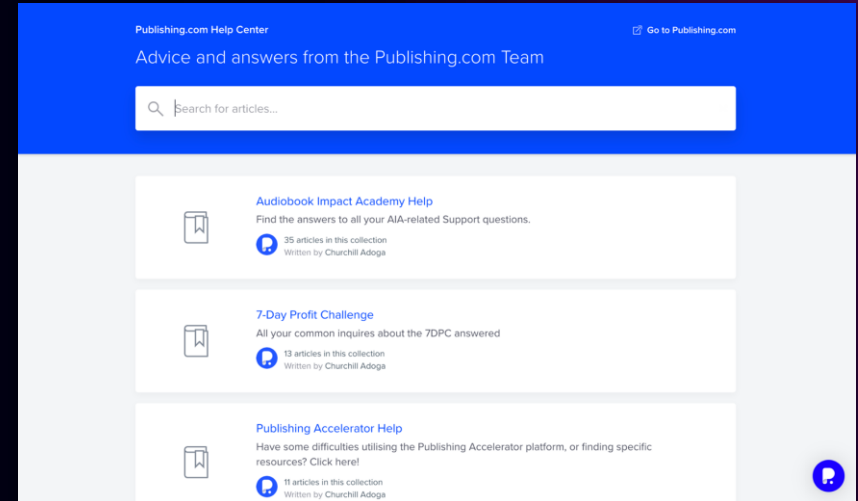

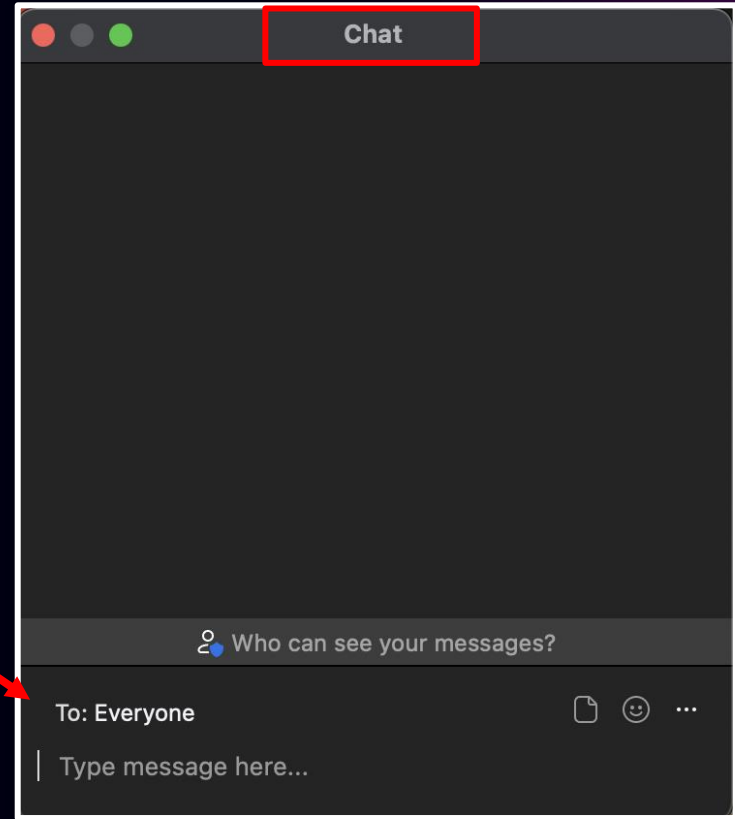

I've noticed that some AIA students do this, maintaining their regular Facebook with real name, and also using a pen name profile. I had thought this is not allowed according to FB policy, but am unsure if I got that idea from the AIA course, or made an assumption.

If permitted, I want to create a FB account with my pen name for personal privacy and to avoid confusion for people on the review team. While reviewers never asked, some were actually completely unfamiliar with the concept of a pen name, and one even accused me of stealing someone else's work.
